#### BAPHR RESPONDS TO SSA

BAPHR members have been involved in responding to the recently proposed new Social Security Administration regulations to address HIV related disability claims. We have met with various community representatives and are working with Paul Di Donato, director of policy at the AIDS Legal Referral Panel.

The proposed regulations have been published in the Federal Register and the public was able to comment on them until mid-February. BAPHR sent the following comments to the Social Security Administration:

"The Bay Area Physicians for Human Rights, founded in 1977 and currently comprised of approximately 200 health care professionals, has intimately involved combatting the effects of HIV disease since the beginning of the AIDS epidemic. Many of our member physicians provide services for large numbers of HIV infected individuals. We are writing to you regarding the proposed SSA Rulings on the disability evaluation of persons infected with HIV. BAPHR is supportive of some of the proposals, specifically that HIV infection can be established not solely by antibody testing but alternatively by medical physical history, examination, exclusion of other causes, and treating source opinion. Similarly, we support the decision to accept the diagnosis of pneumocystis carinii pneumonia in the absence of histology or cytology, on the basis of

clinical impressions, response to treatment and medical judgment.

On the other hand, we are concerned that the proposed HIV listing for adults contains significant problems that will hinder our patients in the procurement of much needed benefits. The description of examples of "marked" functional limitations. defined as the inability to perform activities "most of the time". means that the listing requirement for two such areas of marked impairment is excessively stringent Additionally, the new rulings indicate that these two functional criteria are to be combined with an HIV-related disease process which in itself imposes limitation on the individual, (for example, a CD4 count of 200 or less, a fever of 100.4 degrees or more. persistent unresponsive diarrhea, etc.). As a result, the HIV listings are much more onerous than the mental listings, which require only the two functional criteria to be met, without any additional indicators of limitation or severity.

We are concerned about the process for documenting presumptive disability, especially in regard to the use of Form SSA-4814, which appears complicated and error-prone. We believe that requiring this form may very well delay the process, rather than serve to hasten a decision.

We urge a re-examination of these concerns, in the interest of a fair, equitable, and simpler process for our deserving patients."

#### Greetings!

It was good to see many of you at the January 29th BAPHR dinner meeting. The site was great, the food wonderful, and Laurie McBride of the LIFE Lobby presented an informative and helpful talk on challenges upcoming that community will be facing during this Her presentation next year. highlighted the extremely important function of this Lobby, especially in view of the recent increased activity of the religious right. Laurie warned us all that the Traditional Values Coalition and their ilk not only oppose our efforts to secure our legislative rights but fundamentally reject our very right to exist. Her presentation, as well as our own commitment to the efforts and goals of the LIFE Lobby resulted in an unanimous decision by the executive board to continue our membership and financial obligation to the Lobby. The officers look forward to a closer relationship with Laurie and the Lobby in the next few months, with hopeful BAPHR input on important issues.

I want to devote the rest of this 'message' to the ongoing crisis that BAPHR has been facing for the past several years. The current slate of officers are now serving their second vear, and none of them have expressed a desire to serve another term. Despite pressure to continue to remain active in the organization and despite all of the current officers' commitment to BAPHR at this point it appears that none of the current officers will agree to serve another term. I have been attempting to attract "new blood" to serve on the executive board, and I am grateful to the six new members who have come forward. However, at this time, no BAPHR member has expressed any desire to serve as an officer in the coming year. I will continue to attempt to "recruit" members, but I am pessimistic that anyone will come forward and agree to serve the

organization in the capacity of an officer. If that indeed turns out to be the case, we current officers must decide upon a plan of action that will serve to keep the organization in existence. We are currently meeting on a monthly basis and are attempting to formalize suggestions of how BAPHR can continue to function and operate without a new slate of officers. At the very least, it will require a definite re-organization, and perhaps, a fundamental change that will in essence alter how BAPHR functions. Hopefully, members will come forward and agree to serve as officers, but if there does not appear to be any interest, we current officers obligated to meet development. We hope to adopt one or more plans and inform the general membership of our suggestions in the next few months. I personally want to reach out to you for suggestions of any member you may think might want to serve as an officer, and any suggestions that you may have in our attempt to re-organize BAPHR.

On a more optimistic note: we are planning a general membership meeting for early April and hope that Will Roscoe, author of the "Zuni Man-Woman will be available to present a talk on the Shaman and Burdash tradition. Similarities may very well exist between this largely unknown medical tradition among native Americans and our current gay and lesbian identified practices. The date and time of this meeting have not been set as yet, but it appears that Al Baum will host this meeting at his lovely residence.

In May, the officers will host a daylong retreat at the same site in Cazadero that we used last year. Look for further information in the coming months.

On Sunday, June 28th, BAPHR will host a breakfast/brunch get-together at a restaurant within walking distance from the beginning of the Lesbian and Gay Freedom Day Parade. This, I hope will attract more of you to be present, to march with us in the parade. Details will be forthcoming.

We have been working with AAPHR in planning the joint AAPHR/BAPHR Symposium which

will be held here in San Francisco on August 20-22. It should be an informative program, and also a time to get together with fellow AAPHR members. Look for the invite and program in the next several months. Finally, I urge any of who have comments and suggestions to call Brian at the BAPHR office or call me directly at my office or home.

#### REP NEEDED FOR L.I.F.E.

The Lobby for Individual Freedom and Equality is the major gay and AIDS lobby in California and is located in Sacramento, the place of easiest access to legislators and their aides. Their job is to keep the legislative offices informed on issues of importance to both the AIDS community and the lesbian and gay community.

There are three employees in the office in Sacramento, led by Laurie McBride, the executive director who spoke at BAPHR's January meeting.

The responsibility for deciding program and policy issues lies fundamentally with the board of directors, made up of 75-100 members, of which BAPHR is one. Others are predominantly AIDS and gay-related agencies from throughout California, some attorneys whose practices are AIDS and/or gayrelated: and some for-profit CareMark. enterprises such as Annual dues of \$1100 are required for a seat and a vote on the board. Our legal charter allows us to spend a small percentage of our budget on direct attempts at influencing legislation; and \$1100 comfortably under that allowance.

BAPHR currently needs a representative to the board, to participate in policy discussion; and perhaps to be available for direct contact with the staff in Sacramento about current issues. If one chooses to attend board meetings, there are four each year; two in Northern California and two in the south. They are interesting gatherings of

bright and articulate people, of various genders and colors.

As lobbies go, I think this is a competent and effective one, worth the price.

At its February meeting, BAPHR's board decided to extend our membership through 1992.

#### **PCP GUIDELINES OUT**

The USPHS Task Force on Pneumocystis Prophylaxis in Patients with Human Immunodeficiency Infection has released its "Guidelines for Prophylaxis Against Pneumocystis carinii Pneumonia for Persons Infected with Human Immunodeficiency Virus." The report, dated 9 January 1992, was produced by a task force headed by Henry Masur, MD, Chair, and Judith Feinberg, MD, Vice-Chair.

Highlights of the guidelines include recommendations that CD4 cell counts be monitored every three to six months in patients with greater than 200/mm3. Prophylaxis may be considered for patients regardless of CD4 cell counts if they have constitutional symptoms such as thrush or unexplained fever greater than 100 degrees. Any patients who have recovered from a documented episode of Pneumocystis should receive prophylaxis. All patients should be assessed to rule out active pulmonary disease prior to receiving their primary or secondary prophylaxis.

The task force recommended specific treatment regimens using trimethoprim/sulfamethoxazole or aerosolized pentamidine in a dose of 300 milligrams per month, with the stipulation that before aerosolized pentamidine is initiated, patients should undergo an evaluation to rule out tuberculosis. They also suggested that aerosolized pentamidine should be administered to patients with TB only after Tuberculosis therapy has been initiated. Health care workers should consider wearing particulate respirators or masks when administering aerosolized pentamidine.

## CLEAN NEEDLE EXCHANGE LEGISLATION PROGRESSING

In past issues of the BAPHRON, we have reported that BAPHR has taken a strong position of support for Safe Needle Exchange Programs. Assemblyman Willie Recently. Brown and Senator Diane Watson introduced AB 2525 and SB 1418 (with the co-sponsorship of the San Francisco AIDS Foundation and the City of San Francisco) as a first step in legalizing needle exchange in California. Designed to slow the spread of HIV among injection drug users by reducing needle sharing. these bills would allow local jurisdictions to establish a three-year clean needle exchange pilot program without first requesting and receiving authorization from the State Department of Health Services. Because no appropriation is included in the bills, a city or county also would need to have the funding to pay for the program.

Other provisions in the bills are included to alleviate apprehensions that a needle exchange program could encourage IV drug use, and even increase the spread of HIV. Any exchange programs allowed by the bills will be linked to comprehensive HIV prevention programs that include voluntary and anonymous testing, counseling, partner notification and early intervention programs. exchange programs also will be able to serve an important role in referring injection drug users to voluntary treatment programs and other special services. Clean needles would be

provided strictly on an exchange basis, with no needle given out without a dirty needle in exchange.

You can aid the progress of these bills by contacting your local legislator and either thank him or her for supporting one or the other of the bills, or ask that they do so.

#### **RESPITE PROGRAM OPENS**

Laguna Honda Hospital recently announced the opening of a new community service, the Ryan White Respite Program. This program is especially designed for residents of San Francisco with ARC or AIDS who normally receive care in their home and also require 24-hour a day nursing care. Family, friends, and other responsible caregivers can obtain a temporary rest from caregiving with the knowledge that their loved one or patient is in a secure, caring, and medically safe environment. Patients admitted to Laguna Honda Hospital through the Respite Program receive nursing and medical care, diagnostic testing, social services, rehabilitation, and specialty services as needed. Referrals will be accepted from any source, including outpatient clinics, providers, homecare hospice programs, and family and friends of persons with AIDS. Admission may be up to 3 weeks and may be repeated as necessary. The goal of the program is to reduce the need for long term institutionalization of patients who would prefer to remain at home. ## NATIONAL HEALTH CARE REFORM

For the fifth time in this century, Congress is considering ways to rectify the inequities that exist in our system of health care delivery. During this century-long debate, the call for system-wide changes has never been strong enough to ensure that comprehensive health care reform would be successful.

It is unclear whether such a catalyst exists today. our current commitment to providing the best, most advanced health care is being challenged by increasing health care costs rising at a superinflationary rate, the burgeoning of uninsured number and underinsured. and medical malpractice litigation. Perhaps these forces, coupled with a ground-swell, popular movement (such as that recently demonstrated in Pennsylvania's November election and moves to enact health care reform legislation in a number of states) will commit our policymakers to take the steps needed to reform our health care system.

There are many approaches to health care reform ranging from revolutionary to minor adjustments. The 27 health care reform bills now before Congress can be simplified into four categories--employer mandates with public program expan-

sions, government sponsored national health care, tax credits for expanded private health insurance and small market insurance reform. Currently, most of the debate is revolving around the "pay or play" employer mandate and the "single payor" systems (which is based on the Canadian health care system).

Numerous national organizations (e.g. APHA, AMA) have taken strong stands on these issues but, so far, have not come to any agreement. We can be certain that the issue will be hotly debated in the months to come but cannot count on any resolution in the foreseeable future.

#### TUBERCULOSIS AND HIV

As most of us know, there has been a steady rise in the incidence of tuberculosis in the United States over the past several years. As a result of the relationship between HIV/AIDS and TB, many community-based AIDS organizations are finding it necessary to address tuberculosis within their own organizational and programmatic settings. #### ddC APPROVAL UPDATE

The FDA Antiviral Advisory Committee has recommended that the FDA approve ddC for use in combination with zidovudine. In making this recommendation, the Committee expressed its belief that there was not substantial evidence to suggest that ddC should be approved as monotherapy for patients intolerant of zidovudine or ddI, or patients who had progressed on the other antiretroviral agents.

The Committee also voted to utilize proposed new accelerated approval guidelines. Under the accelerated approval guidelines, the FDA has the option to utilize surrogate marker results for accelerated approval of an agent. Subsequently, post-marketing studies will be needed to demonstrate that the surrogate endpoints actually translated into improvement in clinical outcome and/or survival. If such benefits are not seen in the later studies, the FDA can withdraw the drug.

In recommending approval of ddC, the Committee stressed that the clinical trials currently underway need to proceed to their completion in order to provide practicing physicians with the information they need to make intelligent clinical decisions on how best to utilize the newly approved agents.

#### BAPHR REORGANIZATION

The current officers have been working over the past several months to reorganize the structure of BAPHR so that it can respond to the needs of the membership and the community.

Much has changed since the earliest goals of BAPHR were defined. Initially, it was fundamentally a support group, then becoming more visible politically, and later moved into the vanguard of AIDS care. In the last few years, other AIDS service organizations have multiplied to respond to these needs. It is obvious to those of us who have been active in the day-to-day activity of BAPHR that our organization needs now to redefine its mission. Over the past decade almost all BAPHR physicians have been practicing with the burden of dealing with their own health status, and the health and well being of their lovers, friends, and patients. This reality suggests that BAPHR should primarily serve to support the Gay and Lesbian physician, and should strive to make the involvement of each physician in the activities of BAPHR more enjoyable rewarding. It is the premise of each of the current officers that the existence of BAPHR is important, and should continue. It is further the premise that we need to make the functioning of BAPHR palatable to attract the involvement of other officers and physician members.

Despite the overwhelming loss of physicians to illness (over 50 members in the past decade -predominately due to HIV disease), our membership remains strong with over 160 current professional members.

With this in mind, the current officers have recommended the following changes:

- (1) That we change from the present BAPHR Executive Board to a small Board of Directors who will in turn elect a chair, vice-chair, secretary and treasurer. The current officers are willing to be involved in such a board. A change in the By-Laws will be necessary to put this structure in place, and this should be done by the time the term for the current officers expires.
- (2) That existing committees be disbanded. To date, these committees have not functioned efficiently, and have had little participation. The Board can become the committee, and ad hoc committees can be formed whenever a particular concern or activity temporarily becomes a priority.
- (3) That the Board of Directors meet six times a year, on the first Tuesday every two months, and that the meetings occur at the BAPHR office at 4111 - 18th Street, Suite #6. Additional meetings could be convened for special activities.
- That the BAPHRON be (4) published quarterly with a concerted effort to upgrade the quality of each issue, and that additional informational fliers be issued on an asneeded basis.
- That BAPHR function (5) financially within a strict, preplanned budget.
- (6) That the Board of Directors schedule a limited number of thoughtfully planned meetings or events per year, which would include the Annual Awards Banquet.

- (7)That the Board of Directors explore the formation of an informal, non-legal coalition with AAPHR. Over the past several years, AAPHR (which is now celebrating its 10th Anniversary) has acquired national recognition, and has shown ability to deal effectively with social policy, politics, medical/AIDS issues. women's issues, and other human rights issues perhaps more effectively than BAPHR can. Consideration should be given to altering the BAPHR dues structure to reflect closer affiliation with AAPHR, such as an agreement that would allow a renewal in BAPHR to include renewal in AAPHR at some reduced rate.
- (8) That the BAPHR mission statement be revised to reflect that the primary purpose of our organization is professional-social support and education for Gay, Lesbian, and bisexual physicians who are committed to promoting the health and well being of our community.
- (9)That the Board of Directors re-assess BAPHR's CME accreditation with an eve to benefits versus costs in terms of staff time and expense. Should it be discontinued, reliance upon AAPHR for CME accreditation may be explored.

The current officers have thought long and hard about the reorganization of BAPHR. We firmly believe that the very existence of BAPHR is at stake. We are committed to continuing organization, whose existence is an affirmation of gay and lesbian identified physicians. In this perilous time, with attacks on many different fronts, we feel that BAPHR must continue to exist, but it must do so with relevant purpose, and in concert

with the needs and wishes of its individual members.

The current officers welcome any comments, whether written or verbal, from the membership. We urge each of you to either call or write to us and share your views.

## AIDS HISTORY PROJECT UNDERWAY

The AIDS History Project of the UCSF Library and Center for Knowledge Management is a one year, grant-funded venture to examine records accumulated by AIDS organizations in San Francisco. This effort was organized by the AIDS History Project, a collaboration of historians, archivists, AIDS activists, and others interested in preserving the history of the AIDS epidemic. Funded by the National Historic **Publications** and Records Commission, the Records Survey is an initial endeavor which hopes to serve as a model for similar activities elsewhere.

The project gathers information by conducting site visits to agencies, organizations and research projects involved with AIDS. Both active and inactive files are examined to determine their nature. extent. condition, and historical value. This information will provide the data needed to plan for preservation of the most important and vulnerable materials. There is no intent to actually move any records at this time, but the project does hope to initiate a dialogue leading to the eventual placement of historically significant records in suitable archival repositories at a later time.

## HEALTH CARE REFORM: REALITY, NOT A DREAM

- A "Medical Manhattan Project" with one goal: to find a cure for AIDS as soon as possible
- Full funding of Ryan White AIDS programs
- Full implementation of the 1991 recommendations of the President's Commission on AIDS (not one of which has been accepted or acted upon by President Bush)
- Universal health insurance: a core benefit package available to all Americans, with community-wide rating and no discrimination based on age, gender, current health status, or sexual orientation
- Preventive health services: immunizations for all our children; prenatal care for pregnant women; mammogram screening for women at risk of getting breast cancer
- home health care for the elderly ill and the disabled

- Cost containment: reining-in the enormous costs of medical care by limiting profits of insurance and drug

companies; encouraging the use of HMO's; avoiding duplication of expensive technologies; eliminating unnecessary tests and procedures; and cutting through the nightmare of paperwork that adds to the cost of medical practice

- Malpractice tort reform leading to rational liability laws.

Mullighan (a nurse practitioner who has effectively and enthusiastically led Ward 86 at SF General Hospital for the past several years). We also are lining up special entertainment for this night. I hope you will circle this date on your calendar so we can again renew our friendships and enjoy a comfortable, exciting evening lauding the awardees.

Again, thank you for your support, suggestions and confidence during the past two years. As an ex-President/Officer of BAPHR, I will continue to remain active in the organization and, hopefully, continue to help guide it.

the following letter was sent to President-Elect Clinton and other newly elected congressional representatives:

#### Dear President-Elect Clinton:

Congratulations on your recent election to the Presidency. Our organization is excited and enthusiastic over the prospects of working with a compassionate and sympathetic administration.

The Bay Area Physicians for Human Rights, founded in 1977 and currently comprised of 200 health care providers, is dedicated to promoting the health and social concerns of lesbians and gay men. Our organization has long lobbied for the immediate end to the United States military's embarassing and unjustified ban to prevent gays and lesbians from serving openly and with dignity in the armed services.

We have been pleased with your continued commitment to right this injustice, and hope that you will remain firm in your resolve to sign an executive order to end this particular dinosaur of bigotry.

the following letter was received from Annual Dinner Award recipient J.B. Molaghan:

October 23, 1992 was indeed a memorable night for me. Receiving the BAPHR Community Service Award was one of the most humbling and positive experiences of my professional career. I had no idea of what to expect. When Lenny Simpson called me in June to ask if I would receive the award, I was stunned. At first, I thought he was calling for a patient referral, as that is usually the nature of most physician's calls to my office or my home. ## NEW PROCRIT REIMBURSEMENT PROGRAMS ANNOUNCED

Several reimbursement support programs have been established by Ortho Biotech for its anti-anemia product PROCRIT. These include: a Financial Assistance Program which makes PROCRIT available free of charge to all qualified persons who meet specific medical criteria yet lack the financial resources and third-party insurance necessary to obtain treatment. (Details for enrollment are available through the company's free hotline - 1-800-553-3581); a cost sharing service which allows providers and insurers to receive reimbursement for the costs of PROCRIT once an annual cap on the cost of drug has been reached; a reimbursement assurance program which is available to physicians who dispense PROCRIT to qualified non-dialysis patients. In this program physicians will receive PROCRIT in amounts equal to that which a patient has already received while awaiting a reimbursement decision. #### **ACTION ALERT**

Golden Gate University is spearheading a letter-writing campaign by the alumni of West coast and Hawaii college and universities to the presidents of their alma maters to protest the exclusion of lesbians and gays from the Western Association of Schools and Colleges' statement on diversity. As the statement is now written, discrimination based on sexual orientation will be left to individual colleges and universities in California and Hawaii, without risk of losing their accreditation.

The Accrediting Commission Committee on Diversity for Senior Colleges and Universities is recommending exclusion of sexual orientation from its diversity definition (which bans discrimination based on race, ethnic, social and economic backgrounds, disabilities, gender and virtually every other human condition).
